4. 2024 Accomplishments	Last year we hosted the Crime and Justice Initiative Focus Group in January, intended to provide feedback to the Governor's office around our criminal justice system. We had two joint meetings, four Taos meetings, and four Colfax meetings, meeting the statutory requirements and the requirements in our bylaws. We made a quorum for all meetings last year. Two grants were funded by the NM Sentencing Commission's Crime Reduction Act Grant. Behavioral Health working groups in both counties are very active.	
5. Review CJCC Materials Packet	CJCC court staff has prepared an orientation packet to be in alignment with the bylaws that includes a membership agreement and welcome letter. There are agencies that are required to participate pursuant to § 31-28-3. Membership commitments will be renewed and reviewed annually. The purpose of the membership agreement is to identify a representative for your agency, who per our bylaws should be someone with decision making authority, and please identify a proxy in case of absence. 7. Pretrial Services Update- Dominic Martinez	<p>Dominic Martinez introduced the new Pretrial Services Officers, John Vaughn in Taos and Angel Bacca in Raton. Stakeholder meetings have begun. Next one is scheduled for Tuesday 02/18/2025 in Taos and Wednesday 02/19/2025 in Raton both during the lunch hour offered in-person and via google meets. Currently observing arraignments. The plan is to go live with the program in the summer. Stakeholder meetings to take place regularly until then. Any questions can be directed at the team via email, phone, or in-person.</p> <p>The main purpose of the program is to assist individuals to appear for court hearings, decrease recidivism, and help improve access to services prior to disposition. Looking into a grant for transportation with RTD. Transportation is one of the main barriers to getting to court hearings. Some case management but mostly supervision based models. Assisting individuals progress through the case process. NM Sentencing commission grants are open and may be a good avenue for a transportation grant. Pinwheel was awarded a transportation grant from them last year 2024. Training will be provided through the stakeholders meetings. Looking into how violations will be filed in the case. Issues currently in the district adhering to conditions of release due to the many requirements. 	<p>Grant that the BH group was awarded for six months for a pilot program focusing on post-release navigation should assist with the compliance of behavioral health-specific conditions of release.</p> <p>Public Safety Assessment and Background Investigation Report will be done in ABQ upon arrest. They will also be opening cases. The report and assessments will provide more information to assist the Judges in creating informed conditions of release.</p>	
<p>8. Council Current Initiatives</p> <p>a. Behavioral Health Working Group</p> <p>b. Coordinated Community Response Team- Diana Arreola</p>	<p>Active for the last year and a half. Pilot project funded through the NM Sentencing Commission. NEST will be the host agency. Peer support and navigation for individuals from arraignment to post-release. The gap identified was the lack of medicaid and ability to pay for navigation services. Billing structure will be reviewed with the agencies. The navigator will be the initial point of contact to assist with the navigation of services. Will be utilizing the pilot to collect necessary data to help further analyze the community need as well as support the judiciary's work. This project addresses all the identified areas in the strategic plan related to integration of behavioral health in the criminal justice system.</p> <p>Focus Groups for survivors of intimate partner violence in English will be held on April 21, 2025 and in Spanish April 22, 2025. There will be a \$100 stipend for participants. Food and childcare services will also be offered. Flyer to be shared with the draft minutes.</p>	<p>NEST open house in June 2025.</p>
