We have made significant progress in restoring affected systems, and to date, County core systems and functions are fully operational and open to serve County residents. Although our investigation into the incident and its impact remains ongoing, we are able to confirm that the incident was a result of a sophisticated cyberattack. However, at this time, we have not identified any evidence of attempted or actual misuse of the County's data. We continue to work with state officials and federal law enforcement to complete our investigation. Upon completion of our investigation, we will promptly notify any individuals impacted, as required. We continue to greatly appreciate the community's continued support, patience, and understanding as we navigate this incident."</p>	Unanimously approved
